FRONT GARDEN: 1 x Lilac sp. (T1) - Fell to ground level.

2 x Cherry (Prunus sp.) (T4 - T5) - Fell to ground level.

SIDE GARDEN FINCHLEY ROAD: 6 x Robinia pseudoacacia (T9 - T13 & T15) - Raise crowns to 6m above pavement level and prune back overhang from Spring Grove.

1 x Robinia pseudoacacia (T14) - Fell to ground level.

REAR GARDEN: 1 x Ash (Fraxinus excelsior) (T22) - Fell to 1.5m to retain insect hotel.

- 1 x Robinia pseudoacacia (T23) Fell minor stem.
- 1 x Lime (Tilia sp.) (T29) Fell to ground level.
- 1 x Lime (Tilia sp.) (T35) Crown reduce by 30%
- 1 x Plum (Prunus sp.) (T37) Prune back to clear building by 1m

SIDE GARDEN ARKWRIGHT ROAD: 1 x Goat Willow (Salix caprea) (T36) - Fell to ground level.
