T1 London Plane x 1 (Platanus x hispanica) Large mature previously reduced tree to maintain and improve light to several properties.

Suggested works:

- Reduce all round to previous reduction points approx. 3-4m

Rear garden

T2 Beech x 1 (Fagus) This tree has outgrown its location to improve light to gardens and properties.

Suggested works:

- Reduce all round by approx. 3m by reducing the longest branches only leaving a natural outline
- Thin by 15%
