Beech (T1) - thin crown by 20-25% (by removal of small diameter branches). Reason for work is to increase the available light to the front of the property and surrounding area.

Ash (T2) - Prune clear of building by 2m. reason - to allow clearance from building and prevent damage

Elm (T2) - Prune clear of building by 2m

Magnolia (T4) in rear garden - reduce crown by 1m approx. (previous reduction points) - this is routine maintenance in accordance with good arboricultural practise
