OAKESHOTT AVENUE

Outside no.4 - Hawthorn 'Pauls Scarlet' - severe decline and very poor condition - fell and replace with large standard Prunus avium 'Plena'

MAKEPEACE AVENUE

Flank of 49 Hillway - large Silver Birch - nearly dead and very poor condition - fell and replace with large standard tree (species to be finalised)

Outside no. 19 - Indian Bean Tree - reduce lower crown all around by up to 2 metres

MAKEPEACE MANSIONS

South verge Swains Lane end - Lombardy Poplar - reduce crown back to most recent points of reduction (4 metres)

LANGBOURNE AVENUE

Outside no. 3 - Whitebeam in very poor condition and nearly dead with basal decay organism evident - fell and replace with large standard tree (species to be finalised)

ROBIN GROVE

Outside no. 4 - very large Horse Chestnut in severe decline and nearly dead (large dead main stem removed in late 2020) - Fell and replace with large standard English Oak. - URGENT PLEASE CONSIDER UNDER 5 DAY DD NOTICE
