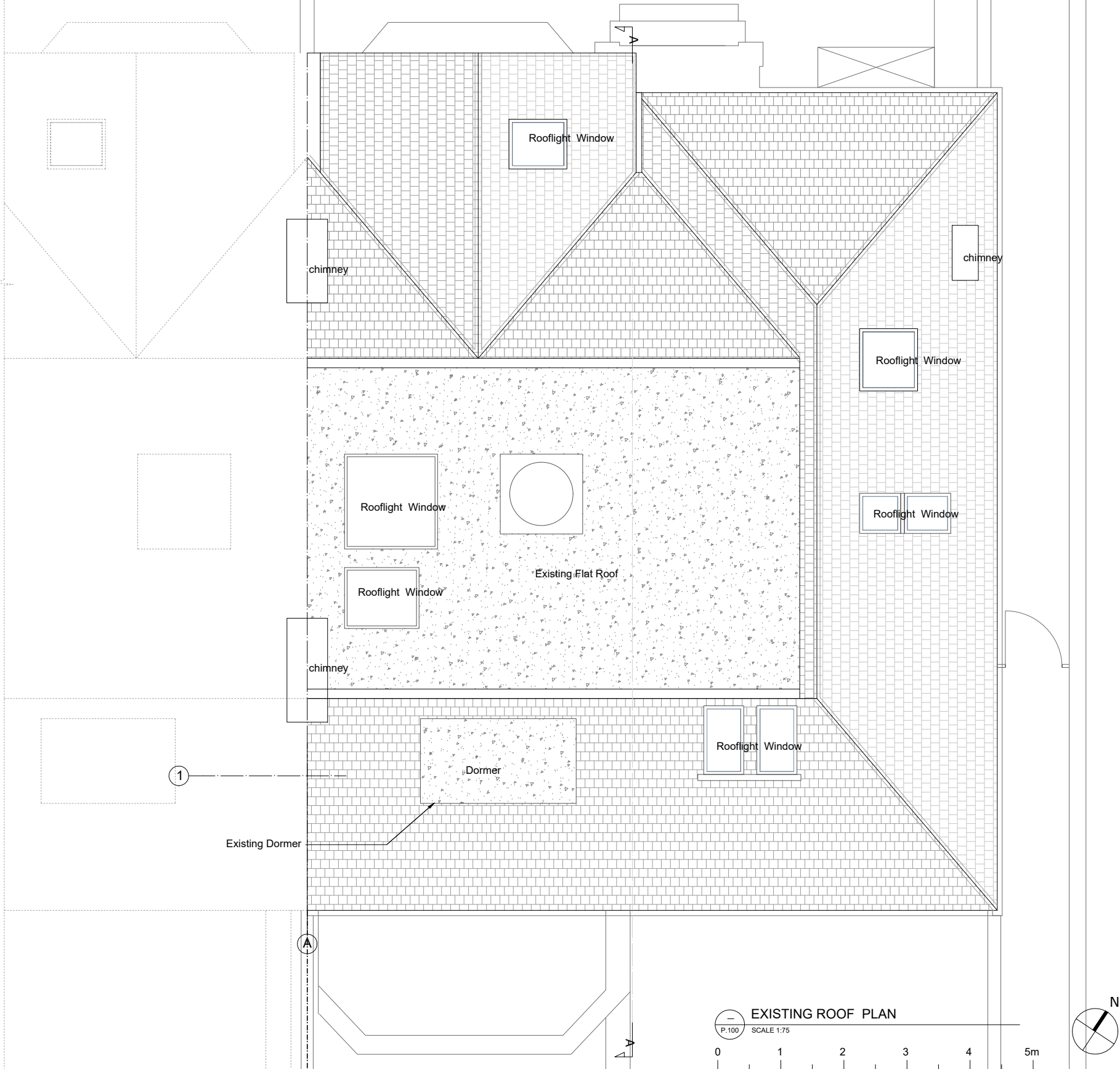

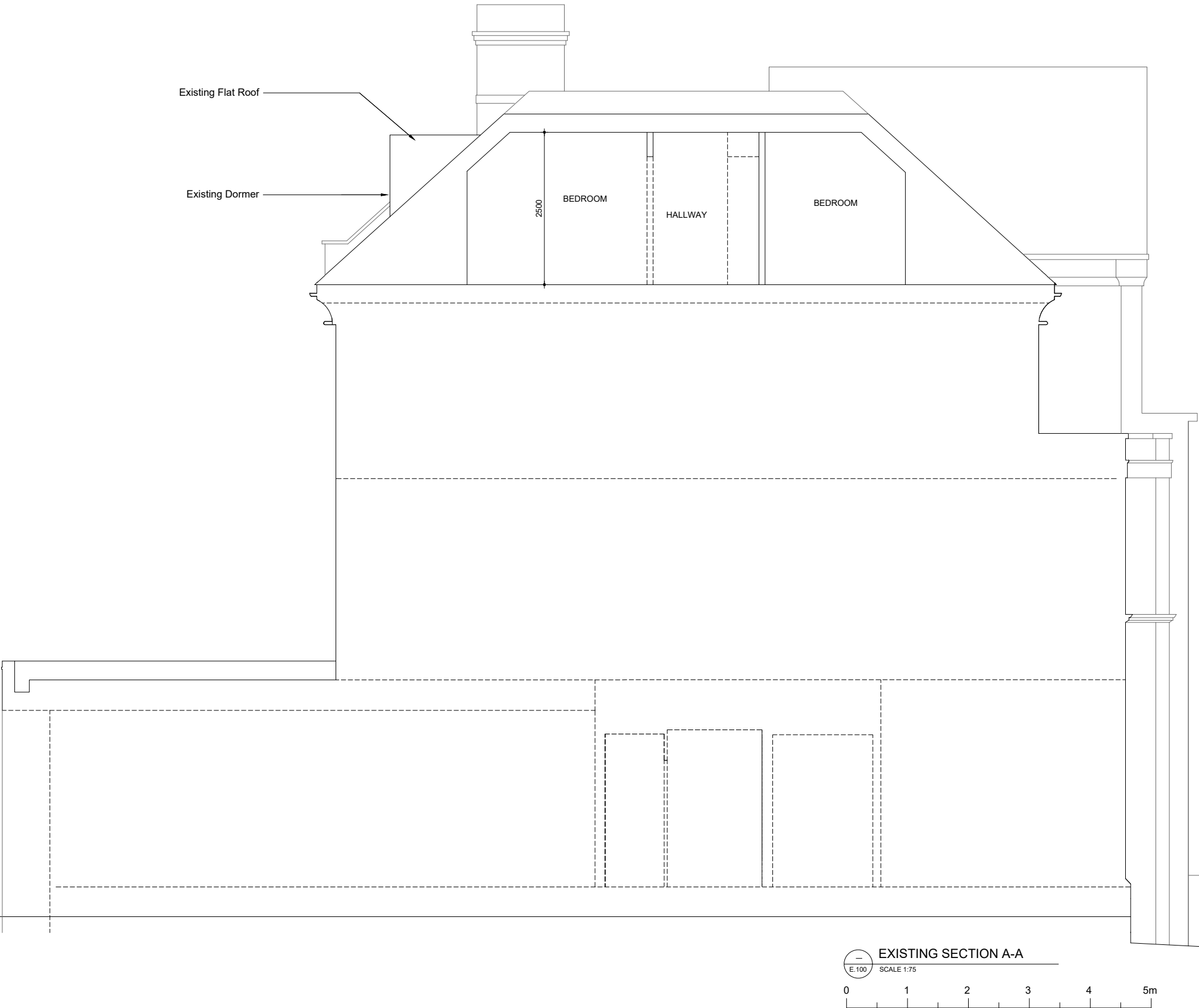
EXISTING SIDE ELEVATION
