T261 - Salix babylonica (Weeping Willow): EW00 - End weight reduction, specified extent - Lateral branch reduction of 1.5m-2m from all aspects (3-4 m total crown diameter) to alleviate mechanical loading of heavy branch weight, specifically cracked lateral limb ("hazard beam"), while ensuring a balanced crown is retained. Height to be reduced where necessary to ensure good form, no greater than 1m.
