Sycamore (T2) - reduce the lowest branch only by 75% leaving a 1.5 metre stem with multiple live growth shoots intact, very minimal work. This branch contributes to excessive shading of next door garden at 110 Priory Road which is caused by canopies of trees T1, T2 and T3.

Horsechestnut (T4) - fell - low amenity value
