Sycamore (T2) - reduce the lowest branch only by 75% leaving a 1.5 metre stem with multiple live growth shoots intact , very minimal work. This branch contributes to excessive shading of next door garden at 110 Priory Road which is caused by canopies of trees T1, T2 and T3.

Horsechestnut (T4) - fell - low amenity value
