- Most thinning cuts will be between 1 and 2 centimetres in diameter Prune TG3 Pleached hornbeams (carpinus betulus) x4 located at the back of property according to the following specifications:
- specifications:Trim to maintain desired shape.
- Prune T9 Olive located at the front of house according to the following specifications:
- Thin crown to remove approximately 15% of live branches to improve light and air penetration through crown.
- Most thinning cuts will be between 1 and 2 centimetres in diameter.
- Reduce crown height and spread by approximately 1-2 metres to enhance natural form.
- Prune T11Acacia located at the right side of property rear garden according to the following specifications:
