Quercus sp.1370Several large cavities at base as well as soil erosion on bank. Discolouration on bark around main stem at base. Major deadwood overhanging footpath and road.Crown reduce by 4m and remove deadwood
Quercus sp.960Large hollow at base able to see through stem. Large dead branch overhanging footpath and road. Lean towards building. Soil erosion on bank.Crown reduce by 2m
