T4 - monkey puzzle tree (1.5m) - reduce crown by up to 0.5m.

T6 - willow leaved pear tree (4m) - reduce overhanging crown by up 0.5m.

T7 - rowan tree (4m) - reduce crown by up to 1m.

T8 - cotoneaster tree (3m) - remove dying branches from crown.
