NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Weeping Ash (*Fraxinus excelsior* 'Pendula') (T1) - Reduce vertical overlong back to previous reduction points. Thin canopy by lifting all round to 2.5m.

1 x Ash (*Fraxinus excelsior*) (T2) - Reduce back to previous reduction points, 1.5m - 2m all-round leaving small furnishing growth.

1 x Himalayan Birch (*Betula utilis*) (T3) - Reduce the height by 1.5m - 2m. Reduce lateral growth by 1m - 1.5m and thin internally.

1 x Ginkgo/Maidenhair (*Ginkgo biloba*) (T4) - Reduce the height by 1m. Reduce lateral growth by 1.5m.

FRONT GARDEN: 1 x Acer spp (T5) - Reduce lateral growth by 0.5m to shape and thin internally.

1 x Holly (*Ilex aquifolium*) (T6) - Trim to create conical shape. Lift by 0.5m - 1m. T

1 x Laurel (*Prunus* spp) (T7) - Reduce height by 1.5m. Reduce lateral growth by 0.5m - 1m.

1 x Laurel (*Prunus* spp) (T8) - Reduce height by 1m. Reduce lateral growth by 1m and shape.

1 x Himalayan Birch (*Betula utilis*) (T9) - Reduce the height by 2m. Reduce lateral growth by 2m.

The Council has considered your notification of intended works to trees dated 08 October 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
