e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 Lime- Crown reduce by approximately 4m back to previous pruning points and remove deadwood >30mm.

To reduce shading, leaf litter and most importantly reduce wind and end weight loading on regrowth points.

T2 Beech-

Reduce height by 2m and lift crown to 4.5m in order to prune away from Birch saplings.

To reduce shading, leaf litter and to bring it more into line with Lime to reduce the wind loading on exposed and non wind firm top of crown.
