e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Mature Sycamore: Approximately 19.00m. Raise crown overhanging No.s 43 & 45 by approximately 2.00m. Thin crown density by 20-25%. Reduce lateral and sub-lateral branches structure (house side) overhanging gardens by approximately 2.50-3.00m. Raise crown over flats side to approximately 2.50m above ground level but not above wall height. Remove dead wood throughout crown.

T2: Mature Sycamore - (Located in No.47): Approximately 19.00m. Raise crown by 2.50m, removing two low branches approximately 12cm diameter at union with the main stem.

T3: Mature Magnolia: Approximately 7.00m. Raise crown by 0.50m by means of removing 1 x low branch growing towards the house.

Reason: General maintenance.

T4: Pittisporum: Approximately 5.00m. Fell to ground level.

Reason: This tree is growing very tall and within close proximity to the house.
