e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Hornbeam (T1). Pollard to maintain the overall canopy sizes of this and neighbouring trees in order to reduce shade and mitigate the risk of subsidence. The work is being completed in accordance with an earlier tree report dated September 2018 which was commissioned after subsidence was found in No 1 Elsworth Terrace. This report recommends that the status quo is maintained between the building, neighbouring trees and the underlying clay soil/bedrock by periodically pruning all or some of the trees. Pollarding this tree will contribute to the mitigation of the risks presented by clay related subsidence. Although subsidence is a consideration at this property the primary objective of this work is to reduce shade and maintain the trees within the scale of the building and its garden.
