Tree no 0842 - Sycamore - Reduce canopy to previous reduction points (6-7m). Reason - Comprehensive cavity in mid stem - open to North. Moderate adaptive growth visible but thin remaining wall evident and exposed material comprehensively altered. Screwdriver pushed in 550mm. Cavity coalesces with additional cavities from old pruning wounds up stem. Tree is a lapsed multi-stage pollard. Historic pollard point at 6m has multiple decay sections associated with it. Some minor branches storm damaged and hung over neighbouring garden.
