Remove all epicormic growth to 5m
T7 - Hornbeam: Remove secondary leader to north at 1.2m height back to main stem to improve long term form / prevent growing against wall
T9 - Holm oak: Remove secondary leader to south at 0.3m back to main stem height to improve form
T11 - Horse chestnut: Crown reduce to previous reduction points - 1.5-2.0m branch lengths retaining soft furnishing growth. Remove all trunk growth to 4m height
