Proposal:

FRONT GARDEN: 1 x Common Hawthorn (*Crataegus Monogyna*) - Fell to ground level.

The Council has considered your application dated 01 November 2021 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 3 Prior to the end of March 2022, a single-stemmed hawthorn tree (*Crataegus monogyna*) shall be planted in the front garden of the property with a stem circumference of 12-14cm at 1m above the rootball and shall be planted no less than 750mm from any structure unless otherwise agreed with the council in writing. The tree shall be planted and maintained in accordance with the standards set out in BS8545:2014. Should the tree die or become seriously diseased within 5 years of planting it shall be replaced in accordance with the specification detailed in this condition.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).

Informative(s):

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works. For further information contact Natural England on 0300 060 4911 or www.naturalengland.org.uk.
