T7 ash - crown reduce back to previously pruned points. Reason - to prevent growth from becoming over crowded and to manage the size of the tree in an area with a high tree population.

T13 ash - remove. Reason low quality tree in an overcrowded situation

T38 lime - reduce height of pollard point by 3m to bring in line with neighbouring limes and crown lift to achieve 6m clearance.
