### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Western red cedar (*Thuja plicata*), 1 x Lime (*Tilia* Spp.) & 2 x Sycamores (*Acer pseudoplatanus*) (G1) - Reduce height to approx. 1m below previous pruning points to leave group standing at approx. 5m tall.

13 x Limes (*Ilia* Spp.) (G2) - Re-pollard trees back to previous points to leave standing approx. 6m tall.

1 x Privet Hedge - Trim down.

1 x Holly (T1) - Fell as close to tree's current ground level as possible and leave the stump in the ground.

The Council has considered your notification of intended works to trees dated 25 October 2021 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
