

BEAD TO MATCH

ALL EXISTING DOOR FURNITURE, LOCKS, LETTER-BOXES, NUMBERS TO BE REMOVED FROM THE EXISTING DOOR, SERVICED AND CLEANED AND INSTALLED INTO THE NEW DOOR.

FINISH TO BE FACTORY PRIMED AND READY FOR ON-SITE PAINTING (I COAT OF WHITE PRIMER). COLOUR TO MATCH EXISTING. DOOR CILLS TO RECEIVE 1 COAT OF LACQUER FOR FINAL POLISHING BY OTHERS.
