e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Within the curtilage of No.6 St Annes Close:

T1: Cherry approximately 5.00m: Fell to ground level. Tree is in decline.

T2: Approximately 7.00m: Remove dead wood throughout. General maintenance.

T3: Ash: Reduce ivy mass back into main stem at a height of 4.00m. Remove dead wood throughout crown. General maintenance.

T5: Not identified (possible Sophora): Approximately 9.00m: Reduce all round by approximately 2.00-2.50m. Thin crown density throughout by approximately 25%. Remove dead wood throughout.

T6: Ash: Approximately 7.00-8.00m: Fell to ground level. This tree has poor form and has been suppressed by a large Poplar growing above it.

T7: Small holm oak: Approximately 3.00m: Reduce by up to 1.50m. General maintenance.

T8: Naturalised area: Approximately 9.00m: Reduce ivy back to main stem at a height of 3.00-5.00m. Reduce dead wood throughout. Ivy advancing up the main stem into the main crown structure of a large Lime. General maintenance.

T9: Leyland Cypress: approximately 13.00m: Sever Ivy by cutting a 30cm swath near to ground level. Ivy beginning to advance into the tree. General maintenance.
