Remove major deadwood

T2 - Horse chestnut

Crown reduce south west lateral over highway by branch lengths of 3-3.5m to retain even and flowing canopy outline Crown reduce north east lateral over no.7 by 2.5-3.0m branch lengths to balance Crown lift to 5m height by pruning maximum 50mm branch diameters  
Remove major deadwood
