The ramp to the south of the building is not required as level access to the entire ground floor may be gained from the front entrance. The extent of the covered walkways has reduced in size to be cost effective and only provide cover to the external areas where it is considered essential to do so. The covered walkways' structure has changed from timber to powder coated aluminium due to the availability of materials and the need to deliver this necessary aspect of the design in a timely manner. The covered walkways' roof panels have changed from clear roofing to translucent roofing to reduce maintenance requirements.
