Sycamore (T00190) - complete fell of twin stem sycamore which is rotten and the base and is in danger of falling. This tree is failing at the base, and removal of this tree will also benefit the mature Ash tree that is under 1 metre away. We ask that this tree be considered under a 5 day notice due to its proximity to paths and monuments, causing danger to both should it fall. Trees will be replanted in line with our Landscape Masterplan.
