e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We would like to reduce the Lime tree in the front of the property by about 6 metres as it is very large for its location. It is overshadowing the garden and stops light going in to the properties. The soot which the leaves emit also causes lots of mess. Reducing the height will also minimise root expansion as the tree is relatively close to the house.
