Thanks for getting back.

I will object it. Please forward my email below.

1. I've requested a FOI, camden's policy documents in regards to pumping out fumes from kitchen extractor.

I know the other councils Croydon and City of London wouldn't allow this, and I attached their policy on previous emails.

2. There is no reason for them to pump out fumes, plenty of other restaurants in Camden have system where the fumes are managed internally.

It's not a planning issue but it's a money issue, premises not willing to spend the extra money, and would rather dump all the fumes and pollution into my air space.

3. They can easily move the air con units elsewhere, onto the floor of their premises for example. Not directly outside my bedroom, leaving it on all day and night.

The previous management, only use to use the air con, when the building was 24c or more. Since the new management, he turns it on 6am, leaves running 12 hours and sometimes forgets to turn it off.

It's 80dbbi measured, and 85db is damage to hearing. Noise comes straight thru the glass and its double glazing aswell, so it's very loud, both machines.

It's like somebody leaving their 2x vacuum cleaners all day, directly outside my bedroom window, 5am, 6am, 7am, 7pm, 10pm, 11pm and refusing to switch it off.

4. They moved in and ripped out all the sound and thermal insulation, turn the speakers on maximum noise and bass. They cause nothing but problems, Make as much noise as possible and refuse to pay for anything. At the same time, wrongly having access to all my internal walls, which are shared. They don't own the shared walls, and have no right to disturb me all day.

I understand your frustrations relating to the extraction equipment, there has been a retrospective planning application submitted with the following description:

Retrospective application to change the use of the ground and basement unit from a mixed A1 (retail), A3 (cafe) and A4 (bar) Sui Generis use to Class E (b) and retention of air-conditioning unit on the rear at first floor level and a cooking extract grille at the rear.

I have just been notified that the application has just been registered today it may take 24 hours or so to be seen online and objections can now be made. Please follow the below link and enter ref 2021/3936/P

carried out to support the application so our environmental team can also make comments as to whether the air con unit and extraction equipment would be acceptable or they may suggest some conditions.
I will forward your email onto the planning officer dealing with the application so they are aware of your concerns when making the initial assessment. Whilst I completely understand your frustrations relating to the works carried out by No. 82 there is not much a I can do in terms of taking formal enforcement action at this time due to the retrospective application submitted. However, I will email the occupier/agent and ask for them to turn off the extraction equipment and air con units when the restaurant is not in use in order to alleviate the current environmental nuisance. I will need to wait until the outcome of the application before I take any formal enforcement action such as serving an enforcement notice.

Hi there,

Just to follow up.

They have put the air con machines, both x2, full blast, 5:44am in the morning, waking me up \underline{today} - 25/10/21. Causing serious disturbance, doing it on purpose, why else turn it on.

Machines are illegal, no planning, and they are not supposed to use the building until 9am.

You can see the chef working 1 minute 14s later on the video and hear the noise from bedroom. I took video - https://www.youtube.com/watch?v=ReqaDu4yjGM

The Council makes a mention here, but nothing is being done.

1. The kitchen extractor is still there, pumping out fumes, via the hole in the wall, and nothing seems to have been done about it.

It's completely dis-respectful, pumping out all this toxic odour into my airspace. It's like breathing in 2nd hand cigarette smoke all day, and i'm unable to stop it.

I'm at risk of developing serious health issues, and headaches. I have no clean air to breathe. It's 100% unfiltered that they pump out all day, I can smell everything.

I want the hole in the wall sealed up as soon as possible. If the fumes are internal (which they're not), then there shouldn't be any objection to sealing up the hole, to prevent them pumping out fumes.

They blast extremely loud music, without proper sound proofing or insulation.

2. I see from the FOI, the kitchen extractor problems have been lost in the system, there has been no recent follow up.

I can see the surveyor emails, he doesn't know what he is talking about, because he keeps asking the council for consultation, and in the emails he has no idea on how much odour is allowed to be pumped out.

See guidelines attached - it's either fully out onto the roof, or it's fully internal, not in between like they currently have. You don't pump out the fumes, from the side of the wall - see photo.

There are toxic gasses that have no odour, this causes lung/breathing problems, headaches, all sorts. This is affecting me. I want it stopped.

If somebody were to inspect the system, or read the noise report, you would see, that all the fumes, exit via the hole, in the side of the wall. If you stand on a ladder, in their courtyard, you will smell it, on Saturday and Sunday, when they are cooking the burgers and chips. There are toxic fumes coming out. It's not just the grease smell.

It doesn't follow national guidelines, and pumping out fumes from the side of the wall is bad design/illegal. Shouldn't be there in the first place. I'm not sure what they put in the plans.

You would hopefully see in the plans that the fumes exit via the side of the wall, near my window. Hence the surveyor, asking how much they're allowed to pump out. (Which is zero). But they still pump it out anyway.

I have attached the menu, video and photos, showing burgers, chips, bacon, fry ups.

As above, The fumes are not internal. you see the fry up, burgers and chips they sell. it's on their website https://www.lumilondon.co.uk/menu

It's not reheated. It's freshly cooked, with all the smells. not agreed in the planning.

3. The whole thing has been very distressing, as I am still getting disturbed everyday by these people.
They wake me up, 6am, 7am, with the air con. They are not even suppose to open, until 9am, as per previous planning.
The smells then come through, then the music bass vibrates, and I can't relax in my own home.
It's making me sick, and completely ruining my life. This has been going on for months now.
4. When they did noise assessment, they left out the air con, and only focused on the kitchen extractor. They are misleading the council planning department.
The "existing equipment" in the noise report aka illegal air con, is 80db loud, they twist the facts when measuring the noise of the kitchen extractor. They should have measured the existing equipment, 2x super sized air con units, and said it was 80db, and the illegal kitchen fan is lower than the illegal 80db etc.
They only focused on the <u>noise</u> of the fan, totally ignoring the <u>odour</u> , coming out of the flue, connected to the kitchen extract fan.
