I pruned the Sycamore tree last month which I received permission for. There was a lot of movement in the tree when I was pruning it. When I removed the ivy which was on the tree I noticed that there is a very weak union at the base of the tree which has made the tree unsafe. We would like to fell the tree as it has become unsafe and dangerous. It is growing about 3-4 metres away from a neighbouring property and would damage it if it did fall. I have attached a photo of the weak union at the base of the tree.
