T1 & T2: 2 x Mature Limes: Remove epicormic growth from base and main stems. Reduce crowns back to previous and most recent reduction points (approximately 1.50m) whilst preserving a suitable amount of furnishing wroth the ensure crown continuity and preserve aesthetic value. Thin crown density by approximately 25-30%. Remove dead wood throughout crown.

T3: Lilac: Thin crown density by approximately 30-50cm. Remove dead wood throughout.
Reasons: General maintenance.
