There are a number of reasons for that;</p> <p>One, a person will have to stand and deal with the people /customers from outside the box, the transaction with the clients will be done on the street/ pavement. Secondly , it will create extra paraphernalia and clutter around the box , extra litter , extra congestion, all associated with such change.</p> <p>The box is a listed unit, next to a listed Garden, the visual impact is of a detrimental importance . The phone box is unsuited as a selling point. It should be left as a historical icon, any modification should be allowed only from inside and not externally ; and what is proposed is a functioning unit that needs a human person to make it work externally, on the street/pavement, creating something it is not . Therefore it is infringing on its status and planning .
