Approx Height - 12m  
Location - Front boundary right hand side of driveway entrance  
Service - Prune  
Work required- remove major deadwood of more than 50mm in diameter and greater than 0.5m in length  
Reason - to remove potential hazards

Tree number - T3  
Tree type - Cherry (prunus spp)  
Approx Height - 8m  
Approx Crown Spread Diameter - 6m  
Location - left hand side of driveway  
Service - Crown Reduction  
Work required- crown reduce back to previous by removing approximately 2m from the height and approximately 1m from the sides  
Reason - as part of continued maintenance

Tree number - T4  
Tree type - Crab Apple (malus sylvestris)  
Approx Height - 6m  
Location - by the middle building overhangs driveway  
Service - Prune  
Work required- prune in the top section which overhangs the driveway by removing approximately 1.5m  
Reason - to reduce overhangs to driveway minimising amount of tree related debris falling onto driveway

Tree number - T5  
Tree type - Sycamore (Acer psuedoplatanus)  
Approx Height - 4m  
Approx Spread - 2m  
Location - Rear boundary in the middle  
Service - Re-pollard  
Work required- Re-pollard back to previous  
Reason - as part of continued maintenance
