T1: Mature Yew: Approximately 11.00m. Reduce crown all round by 1.20-1.80m. Remove ivy from crown structure. Prune large Forsythia to a height of approximately 1.00-1.50m. Removing branches from the crown of the tree to clear. General maintenance

T2 & T3: 2 x Holly Trees: Approximately 8.00m: Reduce by approximately 1.50m. Shape and balance. General maintenance.

T4: Dead Purple plum: Approximately 7.00m. Prune back protruding branches. Remove dead limbs.
