T2 - Sycamore - crown lift over road to 4m to provide clearance for vehicles
T3 - Turkey Oak - crown lift by removing sub laterals only raising current crown by approx 2.5m, shorten lateral growing into adjacent yew tree by 2m to provide separation and increase light into area
T4 - Cherry - fell and stump grind - heavy lean, suppressed by T3
T5 - Bay - crown lift to 3m and shorten overlong laterals to shape to improve aesthetics of the tree and increase light into surrounding beds
Client happy for authority to recommend replacement trees for those felled.
