Prune T2 Cherry located at the back of property according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Reduce crown height and spread by approximately 2-2.5 metres to provide clearance to adjacent building and garden
- Reduce back to previous pruned points
