The Top Flat, 58 Primrose Gardens, London, NW3 4TP has been used as a self contained residential flat for more than 4 years. The space was leased by the applicant to the same tenant for a period exceeding the last 4 years, that tenancy having recently ended. The evidence presented covers a period exceeding 4 years and therefore on the balance of probability the application should be approved as lawful.
