e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1 - Birch Tree – Of average condition growing in an area near a building obstructed from view by a large evergreen Bay Tree that is also hindering its growth. Fell to ground level due to poor location and lack of amenity value.

T2 – Multi Stemmed Bay Tree - Reduce height by approx 2m to previous reduction points. Prune remaining tree to create a tight shape using hedge trimmers. Raise the Crown to an agreed height maintaining screening at back left of tree hiding flats.
