Thank you for your letter/telephone call of 13 January 2022 giving notice that the above tree(s) are considered dead/dying /dangerous and require emergency works.

The Council confirms that the remedial works as described above are exempt from the need for further notifications or any formal application to the Council and you are therefore allowed to proceed.

Informative(s):

- 1 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 2 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works. For further information contact Natural England on 0300 060 4911 or

Conditions and Reasons:

- 1 Prior to the end of March 2022, a London plane tree (*Platanus x acerifolia*) shall be planted within 10m of the application tree as an extra heavy standard with a girth size of 16-18cm in circumference at 1m above the root ball unless otherwise agreed with the council in writing. The tree shall be planted no less than 1m from any structure and shall be planted and maintained in accordance with the standards set out in BS8545:2014.

Reason: To comply with section 206 of the Town and Country Planning Act 1990.
