## Conditions and Reasons:

Prior to the end of March 2022, a London plane tree (Platanus x acerifolia) shall be planted within 10m of the application tree as an extra heavy standard with a girth size of 16-18cm in circumference at 1m above the root ball unless otherwise agreed with the council in writing. The tree shall be planted no less that 1m from any structure and shall be planted and maintained in accordance with the standards set out in BS8545:2014.

Reason: To comply with section 206 of the Town and Country Planning Act 1990.
