T1 Silver Birch x 1 (Betula pendula / alba) To shape and maintain.

- Reduce all aspects of the crown back to previous reduction points approx.2m
- Retain furnishing growth.
- Remove dead and dying branches.
Rear garden
T2 Magnolia x 1 (Magnolia spp) Suggested works:
- Reduce overhanging branches back to the boundary line.
- Reduce from the side of the property to give 1 - 1.5 metres clearance.
