The applicant is seeking to change the alignment of the stone filled gabions in a section of the site to respond to the absence of tree roots discovered during construction. It would build over an area previously identified as being within an Root Protection Area. After excavating the soil as part of the enabling works, no tree roots were discovered which demonstrates that the impact of the proposed change on the tree would be acceptable.
