Ash is also blocking a lot of light from both 62+64 Gaisford. tree is also leaning slightly towards 64 Gaisford. tree is approx 16-18m tall 8-10m spread, we would like to remove at least 3-4m from the top and then balance the crown accordingly pruning roughly 2-3m from the sides. pruning in line with bs3998
