Sever ivy and remove ivy from tree.

- The works are part of a regular maintenance programme to retain the tree at a suitable size for its location.
- The subject tree is of a large spreading nature straddling garden.

Rear Garden of Number 36

T3 - Tree of Heaven

Prune back from garden.

- The tree is located in the rear garden of number 36
- The works are part of a regular maintenance programme to retain the tree at a suitable size for its location.
- The subject tree is of a large spreading nature straddling garden.
