Dawn redwood (T1) – Reduce crown by 2-2.5m on all aspects, ensuring a natural canopy outline. The tree has been unpruned for many years and is becoming leggy. It dominates the garden and all surrounding gardens. Pruning will maintain the longevity of the tree, let more light into all the adjacent gardens and restrict the root growth of the tree.
