Rear Garden:

T1: Birch: Approximately 7.00m. Reduce crown by approximately 1.00-1.50m. Raise crown by upto 1.50m. Thin crown density by 20%. General maintenance.

T2: Birch: Approximately 7.00m. Remove weak and partially suppressed front stem. Raise crown by 1.00m. Reduce crown by approximately 1.00-1.50m. Thin crown density by 20%. General maintenance..

T3: Birch: Approximately 4.50m. Reduce crown by approximately 1.00m. Raise crown by approximately 1.00m. Thin crown density by 20%. General maintenance.

T4: Malus: Approximately 3.50-4.00m. Raise crown to main break. Thin crown density by 20%. Reduce extraneous branches back into main crown structure and tidy (approximately 30-50cm). General maintenance.

T5: Mature Sycamore: Approximately 13.00m. Remove 2 x developed basal suckers. Remove dead wood throughout crown. Raise low limb over vegetable patch (growing towards house) by approximately 1.50m. General maintenance.

Rear Garden/Right hand boundary:

T6: Willow: Approximately 8.00m. Reduce lateral and sub lateral branch structure over lawn by approximately 1.00-2.00m. Remove dead wood throughout. General maintenance.

T7: Small Holly: Approximately 3.00m. Trim to shape and tidy. Reduce crown by approximately 0.5m. General maintenance.

T8: Mature Lime: Approximately 13.00m. Remove major dead wood throughout crown. Remove ivy. General maintenance.

T9: Chestnut: Approximately 15.00m. Remove major dead wood throughout crown. Remove ivy. General maintenance.

T10: Chestnut: Approximately 13.00m. Remove major dead wood throughout crown. Remove ivy. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

## Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
