Prune T1 Mulberry located at the back of property according to the following specifications: • Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure. • Thin crown to remove approximately 15% of live branches to reduce crown density. Most thinning cuts will be between 1 and 3 centimetres in diameter
