T3 - Purple Cherry Plum - Fell - tree is dead and has Honey Fungus present at base. T5 - Sycamore - Fell - twig growth is sparse and there is a large amount of deadwood, indicating that the tree is starting to decline. T6 - Lime - Reduce by around 4m back to previous topping points. T7 - Lime - Fell - has major deadwood in the crown and a large decay cavity in the upper trunk where it was previously pollarded in the past. T16 - Fell - has very sparse twig growth and a large area of dead bark on the trunk. T21 - Sycamore - reduce upper crown by around 3m to lesson the load on the fork and install flexible bracing. T26 - Sycamore - reduce upper crown by around 3m to lesson the load on the fork and install flexible bracing.

T48 - Lime - remove dead wood

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
