The plan for 17 Chalk Farm Road is to open a high-end Tattoo & Piercing Shop.

The shop will be organized as follows:

- The ground floor will remain retail shop
- Basement will become a treatment room
- The first floor will become a treatment room
- The second floor will remain storage space

To match the criteria of Camden Council, tattoo shops require a Special Treatment Licence. To issue a Special Treatment Licence, the premises have to be on the right class of use.

Currently, all floors of the building are classified as E1 retail. We are planning to change the use of the basement and the first upper floor, from class E1 retail to Sui Generis, whilst the ground floor and the second floor will remain E1. We will obtain a mixed-use building, without alterations to the structure of the building.
