The tree is a Thorny Acacia located in the front garden of No 87 Gloucester Avenue, NW1 8LB. It has grown to well over 25m in height was several branches overhanging the pavement			
We would like to trim the height back to about 15m and remove any lower branches overhanging the pavement.			
The tree has been pruned previously, with consent, and the level at which previous work has been done is visible and that's the level to which we would again want to prune the tree			
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
