Tree number - G1 Tree type - 2x Sycamore (Acer pseudoplatanus) Approx Height - 12m Approx Crown Spread Diameter - 9m Location - Right hand boundary Service - Crown Reduction Work required- Reduce and shape height by around 2m and reduce spread by upto 1.5m, pruning to suitable growth points/branch fork junctions Reason - To rebalance and shape trees, to encourage best form

Tree number - G2 Tree type - 2x Chestnut (Aesculus hippocastanum) Approx Height - 17m Approx Crown Spread Diameter - 14m Location - Front boundary Service - Crown Reduction Work required- Reduce crowns all round by upto 2m, pruning to suitable growth points/branch fork junctions. Remove major deadwood over 40mm diameter or 1m in length. Lift crowns to ensure 2.5m ground clearance. Reason - To maintain at a reasonable size for the space and reduce encroachment over adjacent road while keeping a reasonably balanced crown. To give adequate clearance over footpaths

Tree number - G3 Tree type - 3x Prunus sp. Approx Height - 8m Approx Crown Spread Diameter - 8m Location - Front boundary Service - Crown Reduction Work required- Reduce and shape crowns by around 1.5m Reason - As part of regular cyclical maintenance, to shape and tidy

Tree number - T1 Tree type - Cherry (Prunus avium) Approx Height - 7m Location - Right hand boundary Service - Prune Work required- Prune to give 0.5m clearance from adjacent building Reason - to give clearance

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
