Although flat 301 is listed on the application address the works are required by the management of England's Lane Residence and not an individual property. We were unable to just select the actual building as a whole.

T1: (courtyard) London Plane: Reduce height no further than previous points of reduction, retaining furnishing growth to create a natural flowing canopy outline.

T2: Ash (corner of England's Lane) Remove new growth back to previous points of reduction.

T3: Ash (Haverstock Hill) Reduce by 2 metres circa, retaining furnishing growth to creat a natural flowing canopy outline.

T4: Ash (Haverstock Hill) Remove new growth back to previous points of reduction.

Works required as triennial maintenance and to allow more light into the properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
